## 2. HOURS AND SCHEDULE

- **Operating Hours:** 8:30 AM – 3:30 PM, Monday through Friday.
- **Late Pick-up Policy:** A fee of \$5.00 for the first 5 minutes and \$1.00 per minute thereafter applies after 3:30 PM.

## 3. TUITION AND FEES

### FOUNDING FAMILY LEGACY RATE

As a "Founding Family" of the inaugural August 2026 class, the tuition rate selected above is locked for the duration of your child's continuous enrollment at Le Marmouset. This "Legacy Rate" is exempt from future annual tuition increases, provided enrollment remains uninterrupted.

Please **check** the box for your child's scheduled attendance:

**Full-Time (5 Days/Week):** Monday – Friday | **\$1,500 / month**

**Part-Time (4 Days/Week):** **\$1,300 / month**

**Part-Time (2 Days/Week):** **\$850 / month**

- **Registration Fee:** A non-refundable fee of **\$500** is required to secure enrollment. (To be applied to the first month's tuition).
- **Payment Due Date:** Tuition is due on the **1st of each month**. A late fee of \$25 applies if payment is received after the 5th.
- **Payment Method:** Tuition is payable via **Venmo @LeMarmouset** or **Check - Le Marmouset LLC**.
- **Continuous Billing:** Tuition is due in full regardless of child absence, sick days, family vacations, or scheduled school holidays/breaks (as outlined in the Family Handbook).

## 4. TERMINATION OF AGREEMENT

- **By Parent:** A **30-day written notice** is required for disenrollment. Tuition is owed for the duration of the notice period.
- **By Provider:** Le Marmouset reserves the right to terminate care for non-payment, persistent safety concerns, or failure to adhere to the Adult Code of Conduct, as detailed in the Handbook.

## 5. LICENSING AUTHORITY (CCL)

The State of California Department of Social Services (Community Care Licensing) has the authority to interview children or staff and to inspect and audit facility records without prior consent.

## 6. ACKNOWLEDGMENT OF POLICIES

By signing this agreement, I/we acknowledge that:

- I have received and read the **Le Marmouset Family Handbook**.
- I agree to the **Health & Illness Exclusion Policy** (24-hour fever-free rule).
- I agree to provide a full legal signature daily on the Sign-In/Out sheet.
- I consent to neighborhood walks and "Garden Laboratory" exploration either with a wagon, stroller or safely attached on a front-loader bike.
- I authorize the application of sunscreen and ointments provided by me.
